**PINDAAN KEPADA REKOD SINOPSIS BERTERUSAN**  
**AMENDMENTS TO THE CONTINUOUS SYNOPSIS RECORD**

**Pemakluman kepada pemilik kapal dan pengurus syarikat perkapalan**

*Notification to Shipowners and Ship Managers*

**Notis Perkapalan Malaysia 02/2008, SOLAS Peraturan XI-1/5 dan Resolusi MSC 198(80) dirujuk.**  
*Malaysia Shipping Notice 02/2008, SOLAS Regulation XI-1/5 and Resolution MSC 198(80) is referred.*

Jawatankuasa Keselamatan Maritim IMO ke 80, melalui resolusi MSC. 198(80) telah menerimapkai beberapa pindaan kepada Rekod Sinopsis Berterusan (RSB) yang akan berkuatkuasa pada 1 Januari 2009.

*The IMO Maritime Safety Committee 80 (MSC), by resolution MSC. 198(80) adopted amendments to the Continuous Synopsis Record (CSR) which will enter into force on 1 January 2009.*

2. Notis Perkapalan Malaysia (NPM) 02/2008 bertarikh 28 Ogos 2008 menekankan element-element penting pindaan tersebut. Pemilik kapal atau syarikat pengurusan kapal yang mengendalikan kapal dengan tanan kasar 100 dan ke atas dan beroperasi di laluan antarabangsa perlu memohon nombor pengenalan unik IMO untuk syarikat dan pemilik berdaftar daripada *Lloyd's Register-Fairplay* dengan kadar segera.

2. *Malaysia Shipping Notice (MSN) 02/2008 dated 28 August 2008 highlighted the essential elements of these amendments. Registered owners or companies managing ships of 100 GT and above and engaged on international voyages are required to apply for the IMO unique company and registered owner identification number from Lloyd's Register-Fairplay (LRF) at an early convenient date.*

3. IMO telah menyebarkan pindaan kepada format dan garis panduan untuk menyelenggara RSB dalam resolusi MSC. 198(80) (Pindaan kepada RSB) untuk memudahkan pindaan kepada SOLAS Peraturan XI-1/5.

3. *IMO has disseminated the amendments on the format and guidelines for the maintenance of CSR in resolution MSC. 198(80) (Amendments to CSR) to facilitate the amendments of SOLAS Regulation XI-1/5.*

4. RSB akan dikeluarkan oleh Pendaftar Besar Kapal-Kapal. Syarikat dan pemilik berdaftar diminta untuk memohon format baru RSB menggunakan borang yang dikepilkkan.

4. *The CSR will be issued by the Registrar General of Ships. Companies and registered owners are urged to apply for the new format of CSR certificate using the attached form.*
