Notis kepada pemilik kapal, agen, nakhoda, pelaut, pihak pelabuhan, pengusaha terminal minyak, pengimport minyak, syarikat-syarikat insuran dan orang-orang yang berkaitan dengan industri minyak.

Notice to shipowners, agents, masters, mariners, ports, oil terminal operators, oil recipients, insurance companies and persons engaged in the oil industry.

a) **“INTERNATIONAL CONVENTION ON CIVIL LIABILITY FOR OIL POLLUTION DAMAGE, 1992”**; AND

b) **“INTERNATIONAL CONVENTION ON THE ESTABLISHMENT OF AN INTERNATIONAL FUND FOR COMPENSATION FOR OIL POLLUTION DAMAGE, 1992”**

1. Dengan ratifikasi Malaysia kepada Konvensyen Antarabangsa Mengenai Liabiliti Sivil bagi Kerosakan Pencemaran Minyak 1992 (CLC 1992) dan Konvensyen Antarabangsa Mengenai Penubuhan Kumpulan Wang Antarabangsa bagi Pampasan Kerosakan Pencemaran Minyak 1992 (Fund 1992) sila ikuti nota-nota berikutnya.

1. With the ratification of Malaysia to the International Convention on Civil Liability for Oil Pollution Damage 1992 (CLC 1992) and the International Convention on the Establishment of an International Fund for Oil Pollution Damage 1992 (Fund 1992) please be advised of the following notes.

3. Peruntukan CLC 1992 dan Fund 1992 meningkatkan jumlah pampasan yang disediakan bagi mangsa-mangsa kejadian pencemaran minyak. CLC 1992 dan Fund 1992 meningkatkan had liabiliti pemilik kapal dan jumlah yang boleh dibayar oleh Fund 1992.

3. The provision of the CLC 1992 and Fund 1992 increase the amount of compensation available for victims of any oil spill incident. The CLC 1992 and Fund 1992 increase the limit of liability of a ship owner and the amount payable by the Fund 1992.

4. Pemilik kapal dan penerima minyak hendaklah memastikan bahawa mereka faham sepenuhnya obligasi dan tanggungjawab masing-masing di bawah CLC 1992 dan Fund 1992. Pemilik kapal dan penerima minyak adalah diminta untuk mematuhi sepenuhnya keperluan sepertimana diperuntukkan di bawah Akta Perkapalan Saudagar (Pencemaran Minyak) 1994.

5. Sepertimana diperuntukkan di bawah Peraturan-Peraturan Perkapalan Saudagar (Pencemaran Minyak) (Insurans Wajib) 2005, pemilik kapal bagi kapal yang berdaftar di Malaysia yang dilindungi di bawah CLC 1992 perlu memohon dan mendapatkan Perakuan Insurans di bawah Konvensyen ini dari IbuPejabat Laut Semenanjung Malaysia.

6. Sementara, penerima minyak di Malaysia yang tertakluk di bawah Fund 1992 perlu menghantar laporan penerimaan minyak bagi setahun bermula 9 Jun 2005 kepada IbuPejabat Laut Semenanjung Malaysia.

7. Notis Perkapalan Saudagar bilangan JL 4/1995 bertarikh 30 Mac, 1995 hendaklah dibaca dengan ubahsuai mengikut peruntukan-peruntukan di bawah CLC 1992 dan Fund 1992.

4. Ship owners and receivers of oil should be well versed with the conventions especially with regard to their respective obligations and responsibilities under CLC 1992 and Fund 1992. Ship owners and receivers of oil are required to comply fully with the provisions as provided for under the Merchant Shipping (Oil Pollution) Act 1994.

5. As provided for under Merchant Shipping (Oil Pollution) (Compulsory Insurance) (Amendment) Regulations 2005, ship owners of Malaysian registered ships that are covered by the CLC 1992 are required to apply and obtain the Certificate of Insurance under the Convention from the Marine Department Peninsular Malaysia Headquarters.

6. Whereas, receivers of oil in Malaysia that is covered under the Fund 1992 are required to submit a report of oil receipts for the year beginning 9 June 2005 to the Marine Department Peninsular Malaysia Headquarters.

7. Merchant Shipping Notice, JL 4/1995 dated 30 March, 1995 shall be read with such modifications as appropriate in accordance with the provisions of CLC 1992 and Fund 1992.
