SURVEY GUIDELINE AND CERTIFICATION
(ADOPTION OF SURVEY GUIDELINES UNDER THE HARMONIZED SYSTEM OF SURVEY AND
CERTIFICATION (HSSC), 2011)

1.0 Purpose

This notice is to provide the guideline for the implementation of survey and certification of Malaysian Ships.

2.0 Application

All Malaysian Ships shall be surveyed and issued certificates in accordance to the Conventions that Malaysia are party to as follows:

1. Load Lines, 1966 - International Convention on Load Lines, 1966
2. International Convention on Tonnage Measurement of Ships, 1969
3. COLREGS - International Regulations for Preventing Collisions at Sea
4. MARPOL - International Convention for the Prevention of Pollution from Ships
 - Annex I - Regulations for the Prevention of Pollution by Oil
 - Annex II - Regulations for the Control of Pollution by Noxious Liquid Substances in Bulk
5. SOLAS - International Convention for the Safety of Life at Sea
 - IBC Code - International Code for the Construction and Equipment of Ships Carrying Dangerous Chemicals in Bulk
 - IGC Code - International Code for the Construction and Equipment of Ships Carrying Liquefied Gases in Bulk

Standard for the period of validity and survey interval for the above International Conventions are set out in the **Attachment 1**.

3.0 Types of Survey required under the International Conventions listed above:

The types of survey are as follows:

- 3.1. **An initial survey** is a complete inspection before a ship is put into service of all the items relating to a particular certificate, to ensure that the relevant requirements are complied with and that these items are satisfactory for the service for which the ship is intended.
- 3.2. **A periodical survey** is an inspection of the items relating to the particular certificate to ensure that they are in a satisfactory condition and fit for the service for which the ship is intended and also leads to the issue of a new certificate.
- 3.3. **An intermediate survey** is an inspection of specified items relevant to the particular certificate to ensure that they are in a satisfactory condition and fit for the service for which the ship is intended.
- 3.4. **An annual survey** is a general inspection of the items relating to the particular certificate to ensure that they have been maintained and remain satisfactory for the service for which the ship is intended.
- 3.5. **A periodical (annual) and mandatory annual survey** are as same as clause 3.4
- 3.6. **An inspection of the outside of the ship's bottom** is an inspection of the underwater part of the ship and related items to ensure that they are in a satisfactory condition and fit for the service for which the ship is intended.
- 3.7. **An additional survey** is an inspection, either general or partial according to the circumstances, to be made after a repair resulting from investigations or whenever any important repairs or renewals are made.

Owner and RO are instructed that all above stated surveys shall be carried out equivalent to the Guideline under 'IMO Resolution A.997(25)' to survey and certification as required under SOLAS 74/78, MARPOL 73/78 and Load Line 1966.
