Merujuk notis NMPM 13/1999, satu tarikh ujian bertulis telah ditambah bagi gred peperiksaan Pegawai Jurutera Kelas 3 dan Pegawai Jurutera Kelas 5. Tiada ujian bertulis bagi gred peperiksaan Pegawai Jurutera Kelas 4. Tarikh-tarikh baru peperiksaan bagi Perakuan Kekompetenan Laut untuk Dek dan Injin bagi tahun 2000 adalah seperti dalam Lampiran 1

2 Sekiranya tarikh peperiksaan jatuh pada hari Kelepasan Am, peperiksaan tersebut akan diadakan pada hari berikutnya.

3. Semua permohonan untuk mengambil peperiksaan bertulis di Jabatan Laut haruslah dikemukakan di pusat-pusat peperiksaan Jabatan Laut Semenanjung Malaysia atau Jabatan Laut Sarawak (Kuching) atau Jabatan Laut Sabah (Wilayah Persekutuan Labuan), sekurang-kurangnya 30 hari sebelum tarikh peperiksaan.

With reference to notis NMPM 13/1999, there is an additional examination date for Marine Engineer Officer Class 3 and Marine Engineer Officer Class 5. There is no written examination for Marine Engineer Officer Class 4. The amended examination dates for the year 2000 for Certificate of Competency Deck and Engine is as per Attachment 1.

2 *In the event of an examination date falling on a public holiday, the examination date will be forwarded to the following working day.*

3. *All applications for the written examination conducted at the Marine Department has to be forwarded to the Peninsula Malaysia Marine Department examination centres or Marine Department Sarawak (Kuching) or Marine Department Sabah (Labuan Federal Territory) at least 30 days before the date of the examination.*
