## **Merchant Shipping (Amendment) Act 1973 [Repealed By Act A792]**

### **Section 1. Short title and commencement.**

This Act may be cited as the **Merchant Shipping (Amendment) Act, 1973** and shall come into force on such date as the Minister may by notification in the *Gazette* appoint.

### Section 2. Amendment of section 76.

Subsection (1) of section 76 of the Merchant Shipping Ordinance, 1952 [70/52] (hereinafter referred to as "the Ordinance") is hereby amended -

(a) by inserting immediately after the words "mate of a local-trade ship;" and before the word "helmsman;" appearing in paragraph (a) thereof, the words -

"Skipper (Fishing boats); Skipper (Limited) (Fishing boats)", and

(b) by inserting immediately after the words "third-class engine-driver;" appearing in paragraph (A) thereof, the words "engine-driver (fishing boats);".

### **Section 3. Amendment of section 79.**

Subsection (1) of section 79 of the Ordinance is hereby amended by inserting immediately after the word "mates," appearing in line 2 thereof, the words "skippers (fishing boats),".

### **Section 4. Amendment of section 80.**

Subsection (1) of section 80 of the Ordinance is hereby amended -

(a) by inserting a comma immediately after the words "engineers" thereof; and

(b) by substituting the words "engine drivers or engine drivers (fishing boats)" for the words "or engine-drivers" appearing in line 2 thereof.

### **Section 5. Amendment of section 81.**

Section 81 of the Ordinance is hereby amended by inserting immediately after the word "mate," appearing in line 2 thereof, the words "skipper (fishing boats), engine-driver (fishing boats),".

### Section 6. Amendment of First Schedule.

The First Schedule to the Ordinance is hereby amended -

(a) by inserting immediately after the items relating to "Mate of a local-trade ship -" the following new items -

"Skipper (Fishing boats) -	\$5.00
Written Examination	4.00
Oral Examination	1.00
Eyesight Examination	
Skipper (Limited) (Fishing boats) -	\$5.00
Written Examination	3.00
Oral Examination	1.00"; and
Eyesight Examination	

(b) by inserting immediately after the item relating to "Third-class engine driver" the following new item -

"Engine-driver (Fishing boat) -	\$3.00
Written Examination	1.00".
Eyesight Examination
