EMPLOYMENT ACT 1955

EMPLOYMENT (EXEMPTION) ORDER 1985

IN exercise of the powers conferred by section 2B of the Employment Act 1955, the Minister makes the following order: Act 265.

1. This Order may be cited as the **Employment (Exemption) Order 1985** and shall be deemed to have come into force on the 1st October 1980. Citation and commencement.

AKTA PERLEMBAGAAN (PINDAAN) (No. 2) 1984

PERINTAH WILAYAH PERSEKUTUAN LABUAN (PENGUBAHSUAIAN ORDINAN PERKAPALAN SAUDAGAR) 1985

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 6 (3) Akta Perlembagaan (Pindaan) (No. 2) 1984, Yang di-Pertuan Agong membuat perintah yang berikut:

1. Perintah ini bolehlah dinamakan **Perintah Wilayah Persekutuan Labuan (Pengubahsuaian Ordinan Perkapalan Saudagar) 1985** dan hendaklah disifatkan sebagai telah mula berkuatkuasa pada 16hb April 1984.

2. (1) Ubahsuaian-ubahsuaian yang dinyatakan dalam Jadual, iaitu ubahsuaian-ubahsuaian yang didapati perlu atau bermamfaat oleh Yang di-Pertuan Agong bagi menghapuskan kesulitan-kesulitan atau oleh sebab lulusnya Akta Perlembagaan (Pindaan) (No. 2) 1984, hendaklah dibuat dalam peruntukan-peruntukan Ordinan Perkapalan Saudagar 1952 dan Ordinan Perkapalan Saudagar 1960.

(2) Perundangan subsidiari yang dibuat di bawah Ordinan Perkapalan Saudagar 1952 dan Ordinan Perkapalan Saudagar 1960 hendaklah dibaca bersama-sama dengan perubahan-perubahan yang bersamaan tentang nama-nama atau titel-titel sebagaimana yang perlu untuk menyelaraskan perundangan subsidiari itu dengan Ordinan-Ordinan tersebut sebagaimana yang diubahsuaikan oleh Perintah ini.

CONSTITUTION (AMENDMENT) (No. 2) ACT 1984

FEDERAL TERRITORY OF LABUAN (MODIFICATION OF THE MERCHANT SHIPPING ORDINANCE) ORDER 1985

In exercise of the powers conferred by section 6 (3) of the Constitution (Amendment) (No. 2) Act 1984, the Yang di-Pertuan Agong makes the following order:

1. This Order may be cited as the **Federal Territory of Labuan (Modification of the Merchant Shipping Ordinance) Order 1985** and shall be deemed to have come into force on the 16th April 1984.

Act 4585.

Citation and commencement.

2. (1) The modifications specified in the Schedule, being modifications which appear to the Yang di-Pertuan Agong to be necessary or expedient for the purpose of removing difficulties or in consequence of the passing of the Constitution (Amendment) (No. 2) Act 1984, shall be made in the provisions of the Merchant Shipping Ordinance 1952 and the Merchant Shipping Ordinance 1960.

Modification of Merchant Shipping Ordinance 1952 and Merchant Shipping Ordinance 1960 and subsidiary legislation made thereunder. Act A585. Ord. 70/1952. Sabah Ord. 11/1960.

(2) Subsidiary legislation made under the Merchant Shipping Ordinance 1952 and the Merchant Shipping Ordinance 1960 shall be read with such corresponding alterations as to names or titles as may be necessary to bring the subsidiary legislation into accord with such Ordinances as modified by this Order.

Sections 67 and 68 (3)	(1) Insert after the word "Sabah," the words "the Federal Territory of Labuan,". (2) Substitute for the words "the State concerned" the words "the State or Federal Territory concerned".

Section 207 ... (1) Substitute for the words "and the seal of North Borneo" in subsection (1) the words "and seal".

(2) Substitute for the words "Stipendary Magistrate" the words "President of the Sessions Court".

Section 212 (3) ... Substitute for the words "Supreme Court" the words "High Court".
