PERINGATAN MENGENAI KEPERLUAN MANDATORI PERLINDUNGAN INSURANS ATAU JAMINAN KEWANGAN BAGI SEMUA KAPAL YANG BERADA DI DALAM PERAIRAN SEMENANJUNG MALAYSIA, PERAIRAN WILAYAH PERSEKUTUAN LABUAN DAN/ATAU ZON EKSLUSIF EKONOMI MALAYSIA- AKTA PERKAPALAN SAUDAGAR (PINDAAN DAN PELUASAN) 2-11 [AKTA A1393]

REMINDER ON THE MANDATORY REQUIREMENT OF INSURANCE COVERAGE OR FINANCIAL SECURITY FOR ALL SHIPS INSIDE MALAYSIA PENINSULAR WATERS, FEDERAL TERRITORY OF LABUAN AND/OR THE EXCLUSIVE ECONOMIC ZONES OF MALAYSIA – MERCHANT SHIPPING (AMENDMENT AND EXTENSION) ACT 2011 [ACT 1393]

Sila ambil perhatian bahawa keperluan mandatori perlindungan insurans atau jaminan kewangan bagi semua kapal yang berada di dalam perairan Semenanjung Malaysia, perairan Wilayah Persekutuan Labuan dan/atau Zon Eksklusif Ekonomi Malaysia telah mula berkuatkuasa semenjak 1hb Mac 2014 melalui Akta Perkapalan Saudagar (Pindaan dan Perluasan) 2011 [Akta A1393].

Sila ambil perhatian juga bahawa keperluan mandatori ini juga terpakai kepada semua kapal termasuk kapal Malaysia dan bot berlesen di bawah 300 GT yang beroperasi di dalam perairan yang dinyatakan di atas.

Penguatkuasaan sepenuhnya ke atas keperluan mandatori perlindungan insurans atau jaminan kewangan ke atas semua kapal Malaysia dan bot berlesen akan di jalankan bermula dari

Please be reminded that the mandatory requirement for insurance coverage or financial security for all ships inside Malaysia Peninsular waters, Federal Territory of Labuan and/or the Exclusive Economic Zones of Malaysia has been in force since 1st March 2014 through Merchant Shipping (Amendment and Extension) Act 2011 [Act 1393].

Please also be reminded that this mandatory requirement applies to all ships including Malaysia ships and licensed boats of less than 300 GT operating in waters as described above.

Full enforcement of the mandatory requirement of insurance coverage or financial guarantee on all Malaysian ships and licensed boats shall be carried out with effect from

1hb September 2016 melalui 3 cara utama seperti berikut:

1. Penguatkuasaan secara rambang oleh pihak Jabatan Laut Malaysia dan agensi penguatkuasaan lainnya di dalam kawasan perairan yang dinyatakan termasuk di dalam kawasan pelabuhan dan dermaga;
2. Penguatkuasaan melalui bukti dokumentari semasa permohonan endorsan pelepasan pelabuhan; dan
3. Penetapan sebagai syarat wajib semasa pembaharuan lesen bot.

Sehubungan dengan itu, semua Pemilik dan/atau agen Perkapalan adalah disarankan untuk memastikan keperluan berkenaan dipatuhi sepenuhnya.

Notis ini hendaklah dibaca bersama-sama dengan Notis Perkapalan Malaysia 4/2014 bertarikh 3 Jun 2014.

1st September 2016 through three main methods as follows:

1. Random enforcement by Marine Department of Malaysia and other enforcement agencies in waters as stated including port areas and wharfs;
2. The enforcement through documentary evidences during the application of endorsement for port clearances; and
3. The imposition of mandatory requirements during renewal of boat licenses.

As such, all owners and/or shipping agents are advised to ensure full compliance with the relevant requirements.

This notice should be read together with Malaysia Shipping Notice 4/2014 dated 3 June, 2014.
