## MERCHANT SHIPPING ORDINANCE 1952

DECLARATION UNDER SECTIONS 5 AND 6  
OF THE MERCHANT SHIPPING ORDINANCE 1952

IN exercise of the powers conferred by sections 5 and 6 of the Merchant Shipping Ordinance 1952 [*Ord. 70/1952*], the Minister declares Yan in the State of Kedah as a port within the meaning of the Ordinance.

**Amendment of Legal Notification No. 73 of 1953**

2. For the purpose of defining the port limit, the Legal Notification No. 73 of 1953 [*L.N. 73/1953*] is amended in the First Schedule, in respect of the State of Kedah, by inserting after item 38 the following item:

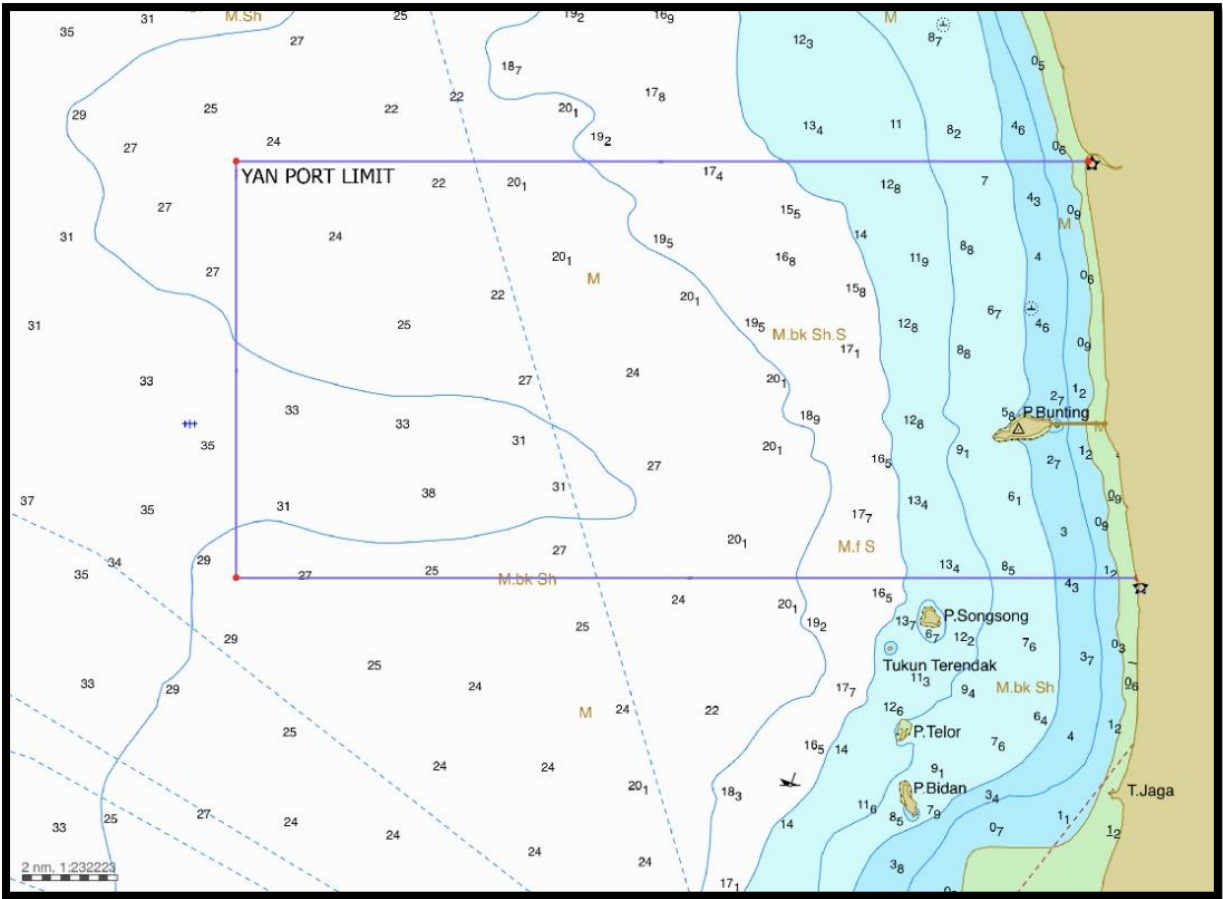
